1. Introduction

The purpose of this document is to inform Submitters of upcoming changes to the Health Insurance Portability and Accountability Act (HIPAA) Eligibility Transaction System (HETS) 270/271 application that will be implemented with the HETS2025-2 release.

2. Overview of Release

The HETS2025-2 release introduces potential changes to the HETS 270 request and HETS 271 response.

The following section documents the planned changes for HETS2025-2.

3. Summary of the Impact on Trading Partners

3.1 Support Additional Preventive Pneumococcal Vaccine (PPV) HCPCS Codes

HETS currently supports four Preventive Pneumococcal Vaccine (PPV) service HCPCS codes (90670, 90671, 90677 and 90732) on the 270 request. Following this release and effective July 2025, HETS will support an additional PPV preventive service HCPCS code: 90684. This will bring the total number of supported PPV preventive HCPCS codes to five (90670, 90671, 90677, 90684 and 90732).

HETS returns prior service history for PPV HCPCS codes; the newly supported 90684 HCPCS code will be handled in the same manner. HETS returns up to ten instances of service (those being the most recent service dates) for supported PPV HCPCS codes.

Note that the scheduled date for the related CWF production deployment is currently July 7, 2025; HETS will not return any prior service history for HCPCS 90684 on the 271 response until after the CWF data feed is updated on July 7, 2025.
