This table provides the data collection time frames and final submission deadlines for the Fiscal Year (FY) 2027 Inpatient Rehabilitation Facility Quality Reporting Program (IRF QRP).\* The first column displays the measure name, the second column displays the data collection time frame, and the third column displays the final data submission deadlines.

The FY 2023 IRF PPS final rule (87 FR 47073)<sup>^</sup> finalized the collection of IRF-PAI assessment data on each patient receiving care in an IRF, regardless of payer. The collection began October 1, 2024 with the FY 2026 IRF QRP. IRFs are required to report these data with respect to admission and discharge of all patients, regardless of payer.
