

Quarterly Update for the Durable Medical Equipment, Prosthetics, Orthotics, and Supplies (DMEPOS) Competitive Bidding Program (CBP) - April 2021

PROVIDER TYPES AFFECTED

This MLN Matters Article is for providers and suppliers submitting claims to the Durable Medical Equipment (DME) Medicare Administrative Contractors (MACs) for Durable Medical Equipment, Prosthetics, Orthotics and Supplies (DMEPOS) items or services Medicare pays for using the DMEPOS fee schedule.

PROVIDER ACTION NEEDED

Medicare updates the DMEPOS Competitive Bidding Program (CBP) files on a quarterly basis to implement necessary changes to Healthcare Common Procedure Coding System (HCPCS) codes, ZIP codes, single payment amounts, and supplier files. CR12128 provides specific instruction for implementing the DMEPOS CBP files.

BACKGROUND

Congress mandated the DMEPOS CBP through the Medicare Prescription Drug, Improvement, and Modernization Act of 2003. The statute required that Medicare replace the current fee schedule payment methodology for selected DMEPOS items with a competitive bidding process. The intent is to improve the effectiveness of Medicare's method for setting DMEPOS payment amounts, which will reduce beneficiary out-of-pocket expenses; and save the Medicare program money while ensuring beneficiary access to quality items and services.

In implementing the DMEPOS CBP, CMS issues update notifications on a quarterly basis. CR 12128 gives the DME MACs the latest update instructions. CMS makes available the competitive bidding files to the DME MACs and the Pricing, Data Analysis and Coding (PDAC) contractor.
