



Quarterly Update for the Durable Medical Equipment, Prosthetics, Orthotics, and Supplies (DMEPOS) Competitive Bidding Program (CBP) - July 2021

PROVIDER TYPES AFFECTED

This MLN Matters Article is for providers and suppliers submitting claims to the Durable Medical Equipment (DME) Medicare Administrative Contractors (MACs) for Durable Medical Equipment, Prosthetics, Orthotics and Supplies (DMEPOS) items or services Medicare pays for using the DMEPOS fee schedule.

PROVIDER ACTION NEEDED

Medicare updates the DMEPOS Competitive Bidding Program (CBP) files on a quarterly basis to implement necessary changes to HCPCS codes, ZIP codes, and single payment amounts. CR12225 provides specific instruction for implementing the DMEPOS CBP files.

BACKGROUND

Congress mandated the DMEPOS CBP through the Medicare Prescription Drug, Improvement, and Modernization Act of 2003. The statute required that Medicare replace the current fee schedule payment methodology for selected DMEPOS items with a CBP. The intent is to improve the effectiveness of Medicare's method for setting DMEPOS payment amounts. This reduces beneficiary out-of-pocket expenses and saves the Medicare program money while ensuring beneficiary access to quality items and services.

CMS issues update notifications on a quarterly basis. CR 12225 gives the DME MACs the latest update instructions. CMS makes available the competitive bidding files to the DME MACs and the Pricing, Data Analysis and Coding (PDAC) contractor. Automated entry of the file additions, updates or deletions are done on a quarterly basis using fully refreshed files, for the following three files:

- Competitive Bidding Area (CBA) ZIP code file
- HCPCS file
- CBA pricing file.
