# **Background**

CMS announces changes in the October 2022 quarterly release of the Laboratory NCD Edit Module for clinical diagnostic laboratory services. The laboratory negotiated rulemaking committee developed the NCDs for clinical diagnostic laboratory services, which we published in a final rule on November 23, 2001.

The NCDs with coding updates in October are:

- Urine Culture, Bacterial (190.12)
- Human Immunodeficiency Virus (HIV) Testing (Diagnosis) (190.14)
- Partial Thromboplastin Time (PTT) (190.16)
- Prothrombin Time (PT) (190.17)
- Serum Iron Studies (190.18)
- Blood Glucose Testing (190.20A and 190.20B)
- Thyroid Testing (190.22)
- Lipids Testing (190.23A and 193.20B)
- Digoxin Therapeutic Drug Assay (190.24)
- Gamma Glutamyl Transferase (190.32)
- Hepatitis Panel/Acute Hepatitis Panel (190.33)
