I. SUMMARY OF CHANGES: The purpose of this Change Request (CR) is to announce coding updates, effective April 1, 2025 for the IPF PPS. This Recurring Update Notification applies to the Claims Processing Manual (CPM), chapter 3, section 190.

II. GENERAL INFORMATION

A. Background: On November 15, 2004, the Centers for Medicare & Medicaid Services (CMS) published in the *Federal Register* a final rule that established the Prospective Payment System (PPS) for Inpatient Psychiatric Facilities (IPF) under the Medicare program in accordance with provisions of Section 124 of Public Law 106-113, the Medicare, Medicaid and SCHIP Balanced Budget Refinement Act of 1999 (BBRA). Payments to IPFs under the IPF PPS are based on a federal per diem base rate which includes both inpatient operating and capital-related costs (including routine and ancillary services), but excludes certain pass-through costs (i.e., bad debts, and graduate medical education). CMS is required to make updates to this IPF PPS annually.

In the FY 2025 IPF PPS final rule, CMS finalized a policy to adopt routine coding updates for the IPF PPS following a sub-regulatory process. This Change Request (CR) identifies routine coding updates that are required as part of that sub-regulatory process. These changes are applicable to discharges occurring on or after April 1, 2025.

B. Policy: April 2025 Coding Updates for the IPF PPS

1. Comorbidity Updates

The April 2025 updates to the ICD-10 code set include the addition of two ICD-10-PCS codes for the Oncology Treatment Procedures list. These codes are listed below:

XW043NA (Introduction of Tarlatamab-dlle Antineoplastic into Central Vein, Percutaneous Approach, New Technology Group 10)

XW033NA (Introduction of Tarlatamab-dlle Antineoplastic into Peripheral Vein, Percutaneous Approach, New Technology Group 10)
