Key to Appendix C:

State Group column = State of residence of therapy user during first therapy encounter.

Therapy User (N) columns = Unique individuals who received the type of therapy (or combination of therapies) described in the column.

Therapy types:

All Therapy Users = Individuals that received PT, and/or OT, and/or SLP services.

PT Users = Individuals that received PT services.

OT Users = Individuals that received OT services.

SLP Users = Individuals that received SLP services.

PT/SLP Users = Individuals that received PT and/or SLP services.

State Distribution (%) columns = Proportion of all therapy users that an individual state represents.

Expenditure Percentile columns = Volume (N) or Distribution (%) of therapy users in an individual state that describe their relative annual therapy expenditures.

Expenditure Groups:

< 10th Expenditure Percentile = Ten percent of therapy users generating the lowest annual therapy expenditures.

10-25th Expenditure Percentile = The fifteen percent of therapy users in the first quartile with annual therapy expenditures greater than the <10th Expenditure percentile group.

25-50th Expenditure Percentile = The twenty-five percent of therapy users in the second quartile of annual therapy expenditures, representing below median expenditures.

50-75th Expenditure Percentile = Twenty-five percent of therapy users in the third quartile of annual therapy expenditures, representing above median expenditures.

75-90th Expenditure Percentile = Fifteen percent of therapy users in the fourth quartile of annual therapy expenditures, representing expenditures above the third quartile.

90-95th, 95-99th, and above 99th Expenditure Percentile = Ten percent of therapy users in the fourth quartile of annual therapy expenditures, representing utilization far above the median.

Green colored cells = Column and row labels and totals.
