

Diabetes Supplies Utilizers

Health Status Outcomes Summary

The Centers for Medicare & Medicaid Services (CMS) continues to observe no negative changes in beneficiary health outcomes resulting from the Medicare Durable Medical Equipment, Prosthetics, Orthotics, and Supplies (DMEPOS) Competitive Bidding Program (CBP).

These materials contain the mortality and morbidity rates for one group of beneficiaries being monitored: the mail-order diabetes supplies utilizer group. “Utilizer Groups” are composed of Original Medicare beneficiaries in the competitive bidding area (CBA) who have a claim for one of the competitively bid products in the month of observation or any of the previous three months.

The health outcomes being measured are deaths, hospitalizations, emergency room (ER) visits, physician visits, admissions to skilled nursing facilities (SNFs), average number of days spent hospitalized in a month, and average number of days in a SNF in a month.

Health outcome rates for the National Mail-Order Recompete (NMORC) CBAs are divided between R1 2017, R2RC, R2021 CBAs, and all the remaining NMORC CBAs (Rest of NMORC). Comparator regions are not used for mail-order diabetes supplies as they were bid nationally. In general, outcome rates in R1 2017, R2RC, R2021 regions and the rest of NMORC CBAs remain similar to each other and their historical rates. The IMPORTANT section of this document further explains the monitoring methodology utilized in developing the Excel file.

Note that mortality and morbidity rates generally display seasonal trends. The first quarter of each year typically has elevated rates of mortality and morbidity; however, the trends generally mirror past seasons and are closely matched by the non-competitive bid regions.

Additionally, rates that appear more variable tend to be based on a smaller number of beneficiaries. For example, the Utilizer Groups have fewer beneficiaries than the Access Groups, so rates for the Utilizer groups tend to be more variable. Note: “Access Groups” include Original beneficiaries who are likely to use one of the competitively bid products on the basis of related health conditions.

IMPORTANT

All DMEPOS Competitive Bidding Program contracts expired on December 31, 2023. As of January 1, 2024, there is a temporary gap in the entire DMEPOS Competitive Bidding Program. During this period, CMS continues to monitor claims rates and health outcomes in the previous Round 1 2017 (R1 2017), Round 2 Recompete (R2RC), National Mail-Order Recompete (NMORC), and Round 2021 (R2021) competitive bidding areas (CBAs) for all previously competitively bid product categories. R1 2017 CBAs (13 total CBAs) and R2RC CBAs (117 total CBAs) were combined as one trend line for continued monitoring of all previous 130 CBAs. Monitoring also continues for OTS Back and Knee braces in the 118 and 117 CBAs (of the former 130) that these products were competitively bid within during R2021. No other changes have been made to the monitoring methodology.

Purpose: To summarize mortality and morbidity outcomes in commode chairs utilizers in R1 2017, R2RC, R2021 CBAs, and non-competitive bid regions aggregated at the DME region level.

Each CSV file in this folder refers to a specific outcome of interest. Each of the outcomes is defined in the Specifications section.

Specifications

Study Population and Definitions

- Utilizer Group: All persons who, during the month of observation, were enrolled in Original Medicare and living in a ZIP code in the specified R1 2017, R2RC, R2021 CBA or the rest of NMORC regions and had a claim for a mail-order diabetes supply in the month of observation or any of the previous three months.¹
- R1 2017 and R2RC CBAs: Includes all areas in which the CBP was implemented for R1 2017 and R2RC
- R2021 CBAs: Includes all areas in which the CBP was implemented for R2021
- Non-Competitive Bid Regions: Includes all regions nationally that are not part of R1 2017, R2RC, or R2021 of the CBP

Outcome Definitions:

- Death: As observed in the Medicare Enrollment Database
- Hospitalization: As indicated by the service date of Inpatient (IP) claims
- ER: As indicated by the service date of Outpatient (OP) claims with an ER flag
- Physician Visit: As indicated by the service date of Carrier (PB) claims
- SNF Admission: As indicated by the date of admission to a SNF
- SNF Days: As indicated by dates on a beneficiary's SNF claims
- IP Days: As indicated by the dates on a beneficiary's IP claims
