

File Layouts for the 2016 Durable Medical Equipment, Prosthetics/Orthotics & Supplies (DMEPOS) and Parenteral & Enteral (PEN) Fee Schedule Public Use Files (PUF)

Section 1834(a)(1)(F) of the Social Security Act mandates, and section 1842(s)(3)(B) of the Social Security Act authorizes adjustments to the fee schedule amounts for DME and enteral nutrition, respectively, furnished on or after January 1, 2016, based on information from the National Competitive Bidding Program (CBP). For certain items, the adjusted fee schedule amounts for items furnished in rural areas within the state will be different than the adjusted fee schedule amounts in other areas of the state. The adjustments to the fee schedule amounts will be phased in based on a blend of 50 percent of the fee schedule amounts that would have gone into effect on January 1, 2016, and the adjusted fee schedule amounts for claims with dates of service January 1, 2016, through June 30, 2016. Effective July 1, 2016, 100 percent of the adjusted fee schedule amount will apply. As a result of these adjustments, the national fee schedule amounts for enteral nutrition will transition to statewide fee schedule amounts. Also a quarterly rural ZIP Code file will be used to determine rural fee schedule payment applicability for 2016 codes with rural and non-rural adjusted fee schedule amounts.

For the rural ZIP Code file, a rural area is defined at § 414.202 to mean:

A geographic area represented by a postal zip code of at least 50 percent of the total geographic area of the area included in the zip code is estimated to be outside any metropolitan area (MSA). The definition of rural area also includes a geographic area represented by a postal zip code that is a low population density area excluded from a competitive bidding area in accordance with the authority provided by section 1847(a)(3)(A) of the Act at the time the rules at § 414.210(g) are applied. Areas outside the contiguous United States are not included in the file as fees are not determined by rural designation.

Because the adjusted fees will be phased in over a period of 6 months, different PUF file formats will be used for the January 2016 update as opposed to the July 2016 and all subsequent fee schedule updates. Revised file formats are provided illustrating the January 2016 and the July 2016 DMEPOS and PEN fee schedule file layouts as well as a rural ZIP Code file in the Excel (.xls) format. The following file names identify the fee schedule and ZIP Code file layouts available for download:

Background: The DMEPOS fee schedule contains fee schedule amounts, floors, and ceilings for each procedure code subject to the DMEPOS fee schedule payment methodology. Although these fee schedule amounts are contained in a single file, their calculations have been mandated by

five separate payment methodologies: DME, prosthetic and orthotic, surgical dressings, splints and casts and intraocular lenses inserted in a physician's office. Beginning January 1, 2016, the DMEPOS and PEN files will also contain those procedure codes that have been adjusted using information from the competitive bidding programs. Note: Fee schedule amounts for those codes not adjusted using competitive bidding information will only have fee schedule amounts in the non-rural (NR) columns.
