RE:	PDP Contracts that are Non-Renewing or Undergoing a Service Area Reduction (SAR) for 2009

The purpose of this communication is to inform you that there are several Prescription Drug Plan (PDP) sponsors that have a contract that is non-renewing or undergoing a Service Area Reduction (SAR) effective January 2009. These include sponsors that will be experiencing one of the following types of contract or plan changes for 2009:

- Voluntary (sponsor-initiated) or involuntary (CMS-initiated) non-renewal of the entire contract for the full service area
- Voluntary (sponsor-initiated) or involuntary (CMS-initiated) non-renewal of only certain portions of the service area under the contract which is considered a SAR
- Voluntary (sponsor-initiated) non-renewal of only certain plans in one or more regions
- Conversion of a contract from offering individual-market products to only offering employer-sponsored products which is considered a SAR

All beneficiaries who will need to select a new plan for 2009 as a result of these changes were notified with a personalized letter which was sent either by the sponsor (voluntary situations) or CMS (involuntary situations) in early October. These beneficiaries have a special election period (SEP) to elect a new plan beginning October 1, 2008, and lasting through January 31, 2009. During this timeframe, individuals may choose to prospectively enroll in a new plan with the following possible effective date options:

While there will be additional contract changes for 2009 due to contract consolidations or novations, affected beneficiaries do not need to select a new plan, and therefore do not have an SEP. These beneficiaries will be notified of any changes to their benefits in 2009 through the Annual Notice of Change mailing.

A table listing the plan and contract changes that will trigger valid SEPs is displayed on the following page. This table provides information about these PDPs including the contract name, the contract number, the state in which the plan will no longer be offered, and the number of beneficiaries currently enrolled in the plan. You may use this information to assist you in determining the appropriateness of SEP requests for beneficiaries wishing to enroll with your organization.
