# **IRF Quality Reporting Data Submission Deadlines**

## When does Inpatient Rehabilitation Facility (IRF) quality data have to be submitted?

Each fiscal year (FY), you must report data to meet Inpatient Rehabilitation Facility Quality Reporting Program (IRF QRP) Program requirements. You must submit your data no later than 11:59 p.m. Pacific Standard Time by the deadlines we've listed below. The IRF-Patient Assessment Instrument (PAI) must be transmitted to CMS through the Assessment Submission and Processing (ASAP) system to the Quality Improvement Evaluation System (QIES). Data for the National Healthcare Safety Network (NHSN) measures must be submitted to the Centers for Disease Control (CDC). No additional data submission is required for the claims-based measures.

CMS strongly encourages all facilities to submit data several days prior to the deadline to allow time to address any submission issues and to provide opportunity to review submissions to ensure data is complete.
