⁵ This may be called the "Gross Savings/Losses percentage." It shows the total savings or losses (first to last dollar) as a percentage of the ESCO's benchmark.

⁶ The ESCO's shares of savings or losses (positive value indicates amount to be paid by CMS to the ESCO, negative value indicates amounts to paid by ESCO to CMS). This amount accounts for several factors: the nature of the ESCO's risk arrangement (the shared savings percentage and shared savings cap) and the reduction of shared savings payments by 2% due to sequestration.

⁷ ESCOs are considered to have successfully reported quality if they completely reported in a given performance year and reported to the ESRD Quality Incentive Program (QIP).

⁸ For Performance Year 1, all quality measures were in pay-for-reporting status. As all ESCOs completed quality reporting, all ESCOs received full quality points.
