This tip sheet highlights information on how and where users will view their ETC Participant Details in the 4Innovation (4i) application.

View ETC Participant Details

Step 1: Click "**My Details**" on the left navigation pane. The page displays your ETC Participant. Users affiliated with more than one ETC participant can view all participants.

Step 2: Click on the participant to navigate to the "**Participation Details**" tab of that participant. The participant's details display in different sections (or cards), as follows:

- Participant Information
- General Information
- Measurement Years (MYs)
- Performance Period Adjustment (PPA) Periods

Note: These sections (or cards) including the Participant Information, General Information, MYs, and PPA Periods are not editable by ETC participants. Please contact the <u>ETC Model Help Desk</u> if any of your information in these sections is incorrect.

- For Managing Clinicians:
 - First Name
 - Last Name
 - Measurement Year the Measurement Year(s) that the participant is/are participating in

The **Measurement Years section** (or card) contains the MY dates from MY1 through MY10 which starts from 01/01/2021 through 06/30/2026. Each MY is a 12-month period and there is a six-month overlap with the prior MY.

The **PPA Periods section** (or card) contains the PPA period dates from 07/01/2022 through 06/30/2027. Each PPA period is a six-month period that corresponds to a respective MY and begins six months after the end of the MY.
