

**PlanCrosswalk2013\_09252012.xls** or **PlanCrosswalk2013\_09252012.txt** – This dataset, available in both Excel and tab delimited text formats, contains the Contract Year (CY) 2012 to CY 2013 plan crosswalk associations identified by plan organizations via the HPMS plan crosswalk module. This file also contains any other plan crosswalk associations approved by CMS. This file does **not** include contracts that become effective 1/1/2013 because they do not have any 2012 enrollment.

<b>Status:</b>  <b>New Plan</b>	<b>Available for:</b>	All Plans	
	<b>HPMS Crosswalk (Definition)</b>	A new plan added for 2013 that is not linked to a 2012 plan.	
	<b>Crosswalk Edits</b>	The new 2013 plan must have a new plan ID number.	
	<b>Example:</b>	<b>CY 2012</b> No plan	<b>CY 2013</b> Plan 003 – county/region A

<b>Status:</b>  <b>Renewal Plan</b>	<b>Available for:</b>	All Plans	
	<b>HPMS Crosswalk (Definition)</b>	A 2013 plan that links to a 2012 plan and retains all of its plan service area from 2012.	
	<b>Crosswalk Edits</b>	<p>The 2013 plan must retain the same plan ID as the 2012 plan.</p> <p>The 2013 plan must retain the same service area as the 2012 plan.</p>	
	<b>Example:</b>	<b>CY 2012</b> Plan 001 – counties/regions A and B	<b>CY 2013</b> Plan 001 – counties/regions A and B

<b>Status:</b>  <b>Consolidated Renewal Plan</b>	<b>Available for:</b>	All Plans (not available for SNPs)	
	<b>HPMS Crosswalk (Definition)</b>	Two or more 2012 plans that consolidate into one 2013 plan.	
	<b>Crosswalk Edits</b>	<p>The resultant 2013 plan ID must be the same as one of the consolidating 2012 plan IDs.</p> <p>The service area of the resultant 2013 plan must have at least one county/region from each of the consolidating 2012 plan service areas.</p>	
	<b>Example:</b>	<b>CY 2012</b> Plan 001 – county/region A  <u>and</u>  Plan 002 – county/region B	<b>CY 2013</b> Plan 001 – counties/regions A and B

<b>Status:</b>  <b>Renewal Plan with an SAE</b>	<b>Available for:</b>	Local MA, MA-PD Plan, and PDP Sponsor employer-only Renewals	
	<b>HPMS Crosswalk (Definition)</b>	A 2013 plan that links to a 2012 plan and retains all of its plan service area from 2012, but also adds one or more new counties.	
	<b>Crosswalk Edits</b>	<p>The 2013 plan must retain the same plan ID as the 2012 plan.</p> <p>The 2013 plan must contain the same service area as the 2012 plan and have at least one new county.</p>	
	<b>Example:</b>	<b>CY 2012</b> Plan 001 – counties A and B	<b>CY 2013</b> Plan 001 – counties A, B, and C

<b>Status:</b>  <b>Renewal Plan with a SAR</b>	<b>Available for:</b>	Local MA and MA-PD Plan Renewals	
	<b>HPMS Crosswalk (Definition)</b>	A 2013 plan that links to a 2012 plan and retains only a portion of its plan service area.	
	<b>Crosswalk Edits</b>	<p>The 2013 plan must retain the same plan ID as the 2012 plan.</p> <p>The 2013 plan must contain at least one county from the 2012 plan.</p> <p>The 2013 plan must <b>not</b> contain at least one county from the 2012 plan.</p>	
	<b>Example 1:</b> <i>Where county B is being reduced from the contract service area</i>	<b>CY 2012</b> Plan 001 – counties A and B	<b>CY 2013</b> Plan 001 – county A
	<b>Example 2:</b> <i>Where county B is assigned to another plan</i>	<b>CY 2012</b> Plan 001 – counties A and B	<b>CY 2013</b> Plan 001 – county A  (Plan 002 - county B is given New Plan status)

  

<b>Status:</b>  <b>Terminated Plan</b>	<b>Available for:</b>	All Plans	
	<b>HPMS Crosswalk (Definition)</b>	A 2012 plan that is no longer offered in 2013.	
	<b>Crosswalk Edits</b>	There is no link to a 2013 plan in the crosswalk.	
	<b>Example:</b>	<b>CY 2012</b> Plan 001 – county/region A	<b>CY 2013</b> No plan

  

<b>Status:</b>  <b>Terminated/ Non-Renewed Contract</b>	<b>Available for:</b>	All Plans	
	<b>HPMS Crosswalk (Definition)</b>	All 2012 plans under a terminated or non-renewed contract are no longer offered in 2013.	
	<b>Crosswalk Edits</b>	Not applicable	
	<b>Example:</b>	<b>CY 2012</b> Plan 001 – county/region A	<b>CY 2013</b> No plan
