

PlanCrosswalk2010_102209.xls or **PlanCrosswalk2010_102209.txt** – This dataset, available in both Excel and tab delimited text formats, contains the Contract Year (CY) 2009 to CY 2010 plan crosswalk associations identified by plan organizations via the HPMS plan crosswalk module. This file also contains any other plan crosswalk associations approved by CMS. This file does not include contracts that become effective 1/1/2010 because they do not have any 2009 enrollment. This file also does not include plans under contracts that are terminating/non-renewing and are not being consolidated into another contract for CY 2010.
