

PlanCrosswalk2011_02112011.xls or **PlanCrosswalk2011_02112011.txt** – This dataset, available in both Excel and tab delimited text formats, contains the Contract Year (CY) 2010 to CY 2011 plan crosswalk associations identified by plan organizations via the HPMS plan crosswalk module. This file also contains any other plan crosswalk associations approved by CMS. This file does **not** include contracts that become effective 1/1/2011 because they do not have any 2010 enrollment. Starting with 2011, this file **now includes** plans under contracts that are terminating or non-renewing and are not being consolidated into another contract for CY 2011.

	HPMS Crosswalk (Definition)	A new plan added for 2011 that is not linked to a 2010 plan.	
	Crosswalk Edits	The new 2011 plan must have a new plan ID number.	
	Example:	CY 2010 No plan	CY 2011 Plan 003 – county/region A

	Available for:	All Plans	
	HPMS Crosswalk (Definition)	A 2011 plan that links to a 2010 plan and retains all of its plan service area from 2010.	

Status: Renewal Plan	Crosswalk Edits	<p>The 2011 plan must retain the same plan ID as the 2010 plan.</p> <p>The 2011 plan must retain the same service area as the 2010 plan.</p> <p><u>NEW FOR 2011:</u> HPMS prohibits a renewal plan to crosswalk to a different plan ID in the plan crosswalk if both plans are under the same contract number.</p>	
	Example:	CY 2010 Plan 001 – counties/regions A and B	CY 2011 Plan 001 – counties/regions A and B

Status: Consolidated Renewal Plan	Available for:	All Plans (not available for SNPs)	
	HPMS Crosswalk (Definition)	Two or more 2010 plans that consolidate into one 2011 plan.	
	Crosswalk Edits	<p>The resultant 2011 plan ID must be the same as one of the consolidating 2010 plan IDs.</p> <p>The service area of the resultant 2011 plan must have at least one county/region from each of the consolidating 2010 plan service areas.</p> <p><u>NEW FOR 2011:</u> Plan consolidations completed in the HPMS plan crosswalk must retain one of the original plan IDs if all plans are being consolidated under the same contract number. This rule does NOT apply for plan crosswalks across contract numbers.</p>	
	Example:	<p>CY 2010 Plan 001 – county/region A</p> <p><u>and</u></p> <p>Plan 002 – county/region B</p>	CY 2011 Plan 001 – counties/regions A and B

Status: Renewal Plan with an	Available for:	Local MA, MA-PD Plan, and PDP Sponsor employer-only Renewals
	HPMS Crosswalk (Definition)	A 2011 plan that links to a 2010 plan and retains all of its plan service area from 2010, but also adds one or more new counties.

SAE	Crosswalk Edits	<p>The 2011 plan must retain the same plan ID as the 2010 plan.</p> <p>The 2011 plan must contain the same service area as the 2010 plan and have at least one new county.</p> <p><u>NEW FOR 2011:</u> HPMS prohibits a renewal plan to crosswalk to a different plan ID in the plan crosswalk if both plans are under the same contract number.</p>	
	Example:	CY 2010 Plan 001 – counties A and B	CY 2011 Plan 001 – counties A, B, and C

Status: Renewal Plan with a SAR	Available for:	Local MA and MA-PD Plan Renewals	
	HPMS Crosswalk (Definition)	A 2011 plan that links to a 2010 plan and retains only a portion of its plan service area.	
	Crosswalk Edits	<p>The 2011 plan must retain the same plan ID as the 2010 plan.</p> <p>The 2011 plan must contain at least one county from the 2010 plan.</p> <p>The 2011 plan must not contain at least one county from the 2010 plan.</p> <p><u>NEW FOR 2011:</u> HPMS prohibits a renewal plan to crosswalk to a different plan ID in the plan crosswalk if both plans are under the same contract number.</p>	
	Example 1: <i>Where county B is being reduced from the contract service area</i>	CY 2010 Plan 001 – counties A and B	CY 2011 Plan 001 – county A
	Example 2: <i>Where county B is assigned to another plan</i>	CY 2010 Plan 001 – counties A and B	CY 2011 Plan 001 – county A (Plan 002 - county B is given New Plan status)

	HPMS Crosswalk (Definition)	A 2010 plan that is no longer offered in 2011.	
	Crosswalk Edits	There is no link to a 2011 plan in the crosswalk.

Status: Terminated or Non-Renewed Contract	Available for:	All Plans	
	HPMS Crosswalk (Definition)	All 2010 plans under a terminated or non-renewed contract are no longer offered in 2011.
